This past year we delivered a record number of meals to our local homebound! We served **39,995** home-delivered meals to local homebound in the

fiscal year of July 1, 2022 to June 30, 2023. For most this is the main meal of their day. Our drives are usually the only person that they see on a regular basis.

### Senior Express Zooms Around Town

The Senior Express provided **4,978** trips in the fiscal year of July 1, 2022 to June 30, 2023. Transportation is a critical program that helps in preserving independence and helps to increase quality of life. With your support we are able to offer a door-to-door service that takes seniors to medical appointments, pharmacy, grocery shopping, and to the Center for lunches and social interactions. Our ridership increased 36.8% compared to the previous year. The demand for this service continues to grow. Seniors are at risk for facing isolation. We served **7,543** in-house lunches in the fiscal year of July 1, 2022 to June 30, 2023. In addition to the delicious lunches a variety of activities are offered.
